PRECAUTIONS FOR USE

ENGINEERING CONTROLS:	Special ventilation is not normally required. However, in the operation of certain equipment or at elevated temperatures mists or vapour may be generated and exhaust ventilation should be provided to maintain airborne concentration levels below the exposure standard.

PERSONAL PROTECTION
